# What is podcasting?

- Comes from the words "iPod" and "broadcasting"
- An audio recording, like a radio show
- Available for download or streaming from a website
- Usually also downloadable automatically via RSS

# Why Podcasting?

- Less Competition
  - 570 Million blogs (7M posts daily)
  - 500 Hours added to YouTube every Minute
  - Only about 850,000 podcasts
- Smartphones make podcasts accessible to millions of people
  - 32% of Americans listen at least monthly
- Able to listen while at work, driving, running, at the gym, etc.
- Your voice connects you personally to your audience
- Connects you to experts and influencers in your industry

## What's The Format?

- Solo pick a topic & talk
- Q&A interview or round-table discussion
- Add music to make it sound professional
  - Can add it "live" using the mixing board (saves some editing time)
  - Can add it in post-production (editing software)
  - Use "Auto Duck" effect to lower the volume of the music when it's over speaking

# After the Recording

- Once I've done the recording, what then?
   Edit the file
  - Audacity (PC or Mac) is free
    Adobe Audition is paid but more powerful
  - Trim the beginning and end
  - Fix any mistakes
  - Remove "umms", long pauses
  - Add music to intro / outro





## After the Recording

- Once I've done the recording, what then?
  - -Transcribe the recording
  - -Post the transcript to your blog or site
  - -Include the MP3 audio file in a player

- 2. Stay consistent (weekly, monthly)
- 3. Ask your audience to subscribe, rate & review
- 4. Post links to your podcast on social media
- 5. Utilize Podcast Advertising
- 6. Use Facebook Promoted Posts / Twitter Ads
- 7. Create a content update email and/or include in your existing email newsletter
- 8. Interview influencers on your podcast
- 9. Be a guest on other related podcasts

# Why Video?

- YouTube is the #2 Search Engine in the world
- Great for:
  - increasing brand awareness
  - building conversations around your brand / firm
  - solving problems for your clients (and potential clients) & answering questions

- 97% of marketers say video has helped increase user understanding of their service or product, which increases brand awareness

## Why Video?

- Video humanizes you and your firm
- People want to work with other people that they know, like, and trust
- 70% of communication is body language, 23% is voice tone and inflection (University of Pennsylvania Study)

## YouTube remains dominant source of video in top Google ranking positions

#### Study found 83% of videos in search results carousel come from YouTube.

There's a perception that Google favors YouTube content above other video sites in search results. A July, 2020 Wall Street Journal <u>analysis</u> found "Google searches placed YouTube videos first in video carousel results by an overwhelming margin . . . [compared with] other video platforms."

An earlier search ranking <u>study</u> from 2017 by Perficient Digital concluded, "YouTube videos rank far more frequently in the top 10 than videos that are either self-hosted, or hosted on other video platforms." And now a follow-up <u>study</u> by Perficient reaffirms these findings.

For its part, Google has repeatedly denied that it gives any preference to YouTube over other sources of video content. Google's Gary Illyes previously <u>said</u> that YouTube ranks well because they "do good SEO, or their pages are structured in such a way that it's easy for us to understand them and to rank."

**Google, YouTube Ranking algorithms 'fundamentally different.'** In the current study, Perficient found that YouTube videos continue to "dominate the videos ranking within Google," especially in video carousels. It also found that the ranking algorithms for video in Google search and on YouTube "are fundamentally different."

The research examined Google search and YouTube rankings for the same roughly 6,100 search queries on both sites. The objective was to "evaluate YouTube's dominance in the Google SERPs and how video rankings vary between YouTube and Google." It determined the ranking algorithms of the two sites were quite different and the top ranked videos (from YouTube) in Google results didn't correspond to YouTube rankings.

July 2020 Wall Street Journal analysis shows 83% of videos in the search results carousel come from YouTube,

### **Transcribe The Video's Spoken Content**

- Upload the transcript to the closed captions
- Post the transcript to your blog

(This is NOT duplicate content, because the closed captions are in a different format and serve a different purpose than website text)





- Good for users with sound turned off
- Good for the hearing impaired
- Indexed by Google as the text version of what is being said in the video
