## What is podcasting?

- Comes from the words "iPod" and "broadcasting"
- An audio recording, like a radio show
- Available for download or streaming from a website
- Usually also downloadable automatically via RSS

# Why Podcasting?

- Less Competition
  - 450 Million Active English-language blogs
  - 100 Hours added to YouTube every Minute
  - Only about 300,000 podcasts
- Smartphones make podcasts accessible to millions of people
- Able to listen while at work, driving, running, at the gym, etc.
- Your voice connects you personally to your audience
- Connects you to experts and influencers

## What's The Format?

- Q&A interview or round-table discussion
- Solo pick a topic & talk
- Add music to make it sound professional
  - Can add it in post-production, but that's a lot of work
  - Easier to add it "live" using the mixing board (saves a lot of editing time)
  - Can do phone interviews via Skype (use the mixing board to send a "mix-minus" out to Skype)



## After the Recording

- Once I've done the recording, what then?
  - Edit the file
    - Audacity (PC or Mac) is free / Adobe Audition CC
    - Trim the beginning and end
    - Fix any mistakes
  - Transcribe the content
  - Post the transcript to your blog or site
  - Include the MP3 audio file in a player

## **8 Podcast Promotion Tips**

- 1. Submit to iTunes, Stitcher, etc.
  - Have 3 episodes live before submitting
- 2. Stay consistent (weekly, monthly)
- 3. Ask your audience to subscribe, rate & review
- 4. Post your podcast to social media
- 5. Use Facebook Promoted Posts / Twitter Ads
- 6. Create a content update email and/or include in your existing email newsletter
- 7. Interview influencers on your podcast
- 8. Be a guest on other related podcasts

- Google loves FAQs and Q&A content, and interviews are perfect for that.
- Make sure your content solves problems & answers client questions
- Podcasting is far less competitive than other types of content & connects you directly to your listeners in a personal, intimate way

- YouTube is the #2 Search Engine in the world
- Great for:
  - increasing brand awareness
  - building conversations around your brand / firm
  - solving problems for your clients & answering questions





- 90% of users say "seeing a video about a product is helpful in the decision process" (Internet Retailer)
- After a video is viewed, 64% are more likely to purchase that product (comscore 2013)
- 50% of users watch business related videos on YouTube once a week
- A third of all online activity is spent watching video



- Video humanizes you and your firm
- People want to work with other people that they know, like, and trust
- 70% of communication is body language, 23% is voice tone and inflection (University of Pennsylvania Study)
- Tester on one of our legal client's sites played the video and said "They seem so nice, and I can tell I'd be comfortable working with them".



- When trying to get PR, local TV wants to see that you are good on camera, and are both knowledgeable and personable.
- National TV wants to see that you've done local TV.



## **YouTube vs Self-Hosting**

### YouTube

- Better visibility in organic search
- Visible across the YouTube platform
- Has lintegration with social media like Facebook and Twitter by default

### **Third-Party Hosting (Wistia)**

- Better analytics, tracking and integration with marketing software e.g. Hubspot, Marketo
- More customizable video players and CTAs
- Ensure links and social shares point back to your site to drive traffic and improve overall site SEO







## **YouTube vs Self-Hosting**

- Google has "whitelisted" YouTube videos, resulting in it being harder for sites to get self-hosted videos in search results
- Most other sites are news sites and sites with largely video content

# Use http:// in the URL so it becomes a link, and place it near the beginning so it's before the "Show More" tab.



## **YouTube Optimization**

#### **Transcribe The Video's Spoken Content**

- Upload the transcript to the closed captions
- Post the transcript to your blog

(This is NOT duplicate content, because the closed captions are in a different format and serve a different purpose than website text)



- Good for users with sound turned off
- Good for the hearing impaired
- Indexed by Google as the text version of what is being said in the video

### **Post To Your Site**

- Heading with video name
- Summary / Intro / Description above the video
- Embedded Video
- Transcript under the video (okay to use same transcript as closed captions)



#### Takeaways

- YouTube is the #2 search engine in the world
- Video humanizes you for potential clients
- Video is the first step to local & national TV
- It's harder than ever to get listed in Google search with 3<sup>rd</sup> party hosted video
- If your content only makes sense in the context of your site, use Wistia for hosting your video files
- Go fix your closed captions today!
